**The preservation of open space through land acquisition and easements: A major multiyear project to support a federal land exchange and accept a conservation easement on Mt Emmons closed on August 29, 2024. With the Mt Emmons project, the Crested Butte Land Trust expanded the conservation portfolio by 885 acres and helped protect critical wildlife, recreation and view corridor for the public. In addition, the land trust acquired 44 acres of private land within Federal National Forests including Congressionally designated Wilderness.**

**Staff monitored and maintained 72 conservation easements and fee owned parcels across 6500 acres. The land trust improved trail conditions supported wildlife habitats, cattle ranching and recreational access for the public. Critical partnerships were enhanced through collaboration with private industry, local governments and mission aligned non-profits.**
